We are looking for board members with experience in human resources, public relations, marketing, fundraising, not-for-profit management, volunteer management, or risk management. We are currently recruiting for all board positions.

Applicants will be contacted by the board chair and screened prior to the acceptance as a board member.

During the screening process, you will be asked to speak briefly about your experience, commitment and highlight the qualities you think would make an ideal board director.

#### **BOARD DIRECTOR DESCRIPTION:**

To provide leadership, governance, and oversight to the operations of Community Volunteer Connections.

## COMMITMENT:

- Each Director is elected to fill a one-, two- or three-year term.
- Directors may stand for re-election to the Board to a maximum of eight consecutive years.
- Each Director is expected to regularly attend six general board meetings a year and join a sub-committee.
- Meetings are scheduled virtually in the evening on a monthly basis.
- Be able to commit 3-5 hours/month.
- Committed to the principles of Islamic teachings and values

## EXPECTATIONS/RESPONSIBILITIES:

Each Director is responsible for good governance and management of the organization.

Board members are stewards of public funds and must act with the highest degree of integrity, accountability and ethical behaviours.

Working with senior staff, directors are expected to participate in annual planning sessions to ensure financial and operational goals are set and met.

Directors are also responsible for participating in committees to ensure policies and the bylaws are updated as needed and that legislation is followed.

Directors are expected to use due diligence in reviewing and approving financial and legal documents, as well as board meeting documents. Directors are also expected to focus on risk mitigation.

Directors provide proper financial oversight by reviewing financial statements, ensuring proper financial controls are in place, and regularly review spending and organizational accounts.

Directors are responsible for recruiting new board members, assessing board performance, and are required to contribute to a respectful and positive board environment through consensus and respectful discussion.

Directors are asked to serve in an executive role (treasurer, secretary, chair, or vicechair) or standing committee, as needed.
