

TERMS AND CONDITIONS

Please review the agreement and requirements below and confirm your understanding of these requirements and regulations.

ENTRY AGREEMENT

Artists must read, understand, and agree to the following terms of the Entry Agreement:

- All works selected will be displayed at the art gala
- If any artist would like to put up their artwork for sale at the art gala to be announced soon, then details can be discussed.
- Please ensure that you have read all the “Terms and Conditions” before proceeding.

CONDITIONS OF ENTRY:

By entering the HMF Art Competition 2024 organized by Healthy Muslim Families, participants agree to adhere to the following entry conditions:

1. Eligibility:

The Competition is open to artists Canada-wide, regardless of age and ethnicity.

2. Submission Requirements:

- The artwork you submit should strictly follow Islamic guidelines in line with the theme for this year, which is *“Islamic Architecture”*.
- Participants may submit as many quality original artworks in any visual art medium as they want.
- Artworks can be previously exhibited, published, or awarded.
- Submissions must not infringe upon the rights of any third party, including copyright, trademark, or privacy rights.
- Each artwork submission must accompany a brief description (up to 150 words) explaining the artistic concept and inspiration.
- Those who cannot send their actual artwork may submit a high-resolution digital image in jpeg, or png format.
- Submissions must be received by **October 10th, 2024, by 12 midnight.**

3. Theme:

Artworks should reflect the theme of “Islamic Architecture.” Participants are encouraged to explore concepts of architecture, Islamic symbolism, and philosophy in their submissions.

4. Entry Fee:

There is no Entry Fee to enter this competition.

5. Submission Process:

Participants must read the terms and conditions (link available on the Google form) and complete the Google forms accompanied by their artwork files with accurate and up-to-date contact information.

6. Ownership and Copyright:

- Participants retain full copyright and ownership of their submitted artworks.
- By entering the Competition, participants grant Healthy Muslim Families the right to use and display the submitted artworks for promotional and exhibition purposes, including, but not limited to, press releases, social media, and marketing materials.

7. Judging and Selection:

- Submissions will be judged based on creativity, originality, technical skill, concept, and adherence to the theme.
- The judging panel will consist of qualified individuals selected by Healthy Muslim Families.
- The panel's decisions are final and binding in all matters related to the HMF Art Competition 2024.

8. Prizes:

- First Place: C\$300
- Second Place: C\$200
- Third Place: C\$100

9. Gallery Display:

The Organizers will be responsible for curating and installing the exhibition at the venue which will be announced soon.

10. Publicity and Promotion:

Participants agree to use their names, artworks, descriptions, and biographical information for promotional and publicity purposes related to the HMF Art Competition 2024 venue, which will be announced soon.

11. Important Dates to Note:

Submission Deadline: **Thursday, October 10th 2024**

Winners Announcement: **Monday, October 14th, 2024**

Gallery Exhibition: To be announced soon.

12. Disqualification:

- Healthy Muslim Families reserves the right to disqualify any submission that violates copyright, contains offensive or inappropriate content, or fails to comply with these entry conditions.
- By submitting an entry to the Competition, participants acknowledge that they have read, understood, and agree to abide by these entry conditions. The Organizer reserves the right to modify, extend, or cancel the Competition for any reason.
